FROM THE COVER

My high school principal told me that I am not getting a planning period. Is this legal?

NO. All teachers deserve a planning period. Moreover, the state is mandated by statute to authorize sufficient funds to provide teachers with a preparation period free of assigned duties. Finally, the Southern Association of Colleges and Schools (SACS), requires that the school includes in the master schedule planning time unencumbered by instruction. My wife and I are employed by the same school district and we're expecting our first child. The school district said that we cannot take 12 weeks of leave each under the *Family and Medical Leave Act* (FMLA). Is this legal?

The FMLA provides an eligible employee up to 12 workweeks of leave during any 12-month period because of the birth of a son or daughter of the employee and in order to care for such son or daughter. However, it also provides that in any case in which a husband and wife entitled to leave are employed by the same employer, the aggregate number of workweeks of leave to which both may be entitled may be limited to 12 workweeks during any 12-month period. For more information regarding the FMLA visit http://www.dol.gov/. The FMLA does not prohibit an employer from providing more generous leave than granted under federal law. You should explore your district's policy manual for additional leave options.

Separately, courts are increasingly recognizing that sex discrimination includes taking adverse action based on gender stereotypes. "Family Responsibility Discrimination" occurs when an employee suffers discrimination at work based on unexamined biases about how employees with family caregiving responsibilities will or should act. In one case, a school psychologist had received outstanding performance reviews until she became a mother. She was denied tenure by supervisors who allegedly made comments to her such as it was "not possible for her to be a good mother and have this job," and they "did not know how she could perform her job with little ones." The court ruled that making stereotypical assumptions about a mother's commitment to her job is sex discrimination. The Equal Employment Opportunity Commission published Enforcement Guidance: Unlawful Disparate Treatment of Workers with Caregiving Responsibilities. The school district claims to have destroyed records related to the election of the school council. Is this legal? NO. O.C.G.A 20-2-85 and 86 provides authority in local boards of education to create school councils that require an election for the teacher representative. Further, the Georgia Government Records Retention Act, O.C.G.A. 50-18-90 et seq., requires local school boards and school districts to have a written record retention schedule for all public records. Thus, destruction of records relating to the election would not comply with Georgia law. A violation of the Georgia Records Retention Act is a misdemeanor.

I am a first grade teacher. My principal will not provide a duty free lunch unless we complete a form indicating a choice whether or not to elect having a duty free lunch. Many teachers feel intimidated and do not receive a duty free lunch. Is this legal? NO. The duty free lunch statute, O.C.G.A. 20-2-218 mandates that all teachers who teach K-5 shall have a 30-minute lunch period free from responsibilities. The statute is mandatory and not discretionary. The law also provides that teachers may, but are not required, to exchange their lunch for any compensation or benefit mutually agreed upon with the school system. Before this break was mandated in 1993, teachers had to spend their lunch period supervising their classes—a chore more stressful than the classroom itself. Quality teachers leave the profession due to stress. Simply put, the duty free lunch law fulfills a vital need. You should contact your UniServ Director for assistance in gaining compliance with this law.

May the principal withhold my monthly pay check contingent upon receiving my lesson plans? Regardless of the school district's claims, it cannot withhold your pay check. You have a legal right to the pay check under the terms and conditions of your employment contract. The school system is bound to the terms of the contract and its deliberate withholding of the entire month's pay constitutes a breach of its obligations under the contract. Further, you have a property interest established through the contact with the school system. The contract establishes a "for cause" requirement for termination or any other disciplinary action as contained in the *Georgia Fair Dismissal Act*. Should you encounter this difficulty, please contact your local GAE representative or your UniServ Director for assistance.

What do I do if I am assaulted by a student? Try to avoid responding physically. If you have to respond physically to defend yourself or to defend another student, you should use reasonable force given the student's age, size and ability to inflict injury. Make sure the situation is stable and have a qualified individual assume your supervisory responsibilities. Document the time, place and circumstances surrounding the attack. Contact your GAE building representative or GAE UniServ Director. Also contact your school nurse and administration. Request that the school system provide you with immediate medical attention Insist that the school system document the attack. Insist that the administration report the incident to local law enforcement. If the district refuses to file a police report, then you should file a police report with the assistance of local association representatives of your UniServ Director. Retain a copy of any report filed with police. Determine whether you should file criminal charges against the student after discussing with an attorney at GAE Legal Services. If you suspect the student will file counter charges against you, do not make or sign any statements or take any other action until you have consulted with your UniServ Director and GAE attorney. You have the right to representation if the district police, the city police, or the county sheriff is going to question you regarding any counterclaim. My repeated requests for assistance with disruptive students have been ignored. Can I bring a camera to my classroom to document their behavior? NO. You must have prior approval from administration. While the question has not been litigated in Georgia's courts, we do know that public school all over the country now use video camera surveillance to document the very student behavior that a teacher would likely document-although those cameras are typically restricted to common areas. It may also be worth asking whether your school district provides notice of the cameras and seeks consent of parents regarding capturing student images at the beginning of the school year. The same kinds of questions arise when photographs of employees are used in the yearbook or on the school website. That said, before bringing your camera to school, you should first obtain the approval from school administration. If you are having problems with teacher and student safety issues, please contact your local UniServ Director (UD) or local Association Representative (AR).


